ARTICLES OF INCORPORATIONARY OF STATE

OF

LEW, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, all of whom are natural persons of full age, citizens of the United States of America and residents of the State of Idaho, have this day voluntarily associated ourselves together, and do hereby and by these Articles of Incorporation unite and associate ouselves together for the purpose of forming a corporation under the laws of the State of Idaho for the purpose hereinafter stated.

Ι

The name of the corporation shall be LEW, INC.

ΙI

The term for which said corporation shall exist shall be in perpetuity.

III

The objects and purposes for which this corporation is organized shall be the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV

The capital stock of this Corporation shall consist of 1,000 shares of nonassessable, common stock, without par value.

The location and post office address of the initial registered office of this corporation in the State of Idaho, shall be 2574 Beverly, Boise, Idaho 83709. The initial registered agent of this corporation is Rodney D. Ledbetter, and his address is 2574 Beverly, Boise, Idaho 83709.
