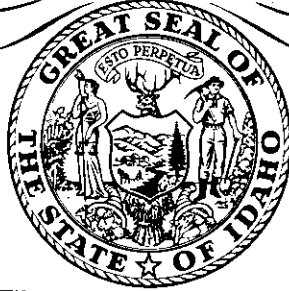

THE UNDERSIGNED, JAMES FOSTER AND MRS FLOYD HIGGINS, THE PRESIDING OFFICER AND THE SECRETARY, RESPECTFULLY, OF A MEETING OF THE BOISE SOUTHSIDE CHURCH OF THE NAZARENE, INC, OF BOISE, IDAHO HELD APRIL 6th 1959 AT 8 O'CLOCK P.M. HEREBY CERTIFY:

THAT THE BOISE SOUTHSIDE CHURCH OF THE NAZARENE, INC, OF BOISE, IDAHO IS A RELIGIOUS CORPORATION ORGANIZED AND EXISTING UNDER AND BY VIRTUE OF CHAPTER 11, TITLE 30, IDAHO CODE: IN ACCORDANCE WITH THE PROVISIONS OF SECTION 30-1103, IDAHO CODE, AT A MEETING OF THE BOISE SOUTHSIDE CHURCH OF THE NAZARENE, INC, BOISE, IDAHO HELD ON APRIL 6th 1959 AT 8 O'CLOCK P.M. presiding officer and the secretary,
respectfully, of a meeting of the
Boise Southside Church of the Naza-
rene, Inc., of Boise, Idaho held April
6th, 1959 at 8 o'clock P.M. hereby
certify:

That the Boise Southside Church
of the Nazarene, Inc., of Boise, Idaho
is a Religious corporation organized
and existing under and by virtue of
Chapter 11, Title 30, Idaho Code: In
accordance with the provisions of
Section 30-1103, Idaho Code, at a
meeting of the Boise Southside
Church of the Nazarene, Inc., Boise,
Idaho held on April 6th 1959 at 8
o'clock p.m. in said Church Annex
at the corner of Euclid Avenue at
Hale Street, Boise, Idaho at which
meeting a quorum of said Church
was present, the corporate name of
the Boise Southside Church of the
Nazarene, Inc., of Boise, Idaho was
