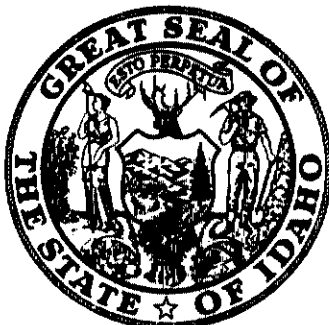

The undersigned, acting as incorporator of a corporation under the Idaho Corporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is PACIFIC WESTERN TRANSPORTATION, LTD.

SECOND: The period of this corporation's duration is perpetual.




