# ARTICLES OF INCORPORATION OF ECHO INVESTMENT, INC.

The undersigned, acting as Incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation.

#### ARTICLE ONE
