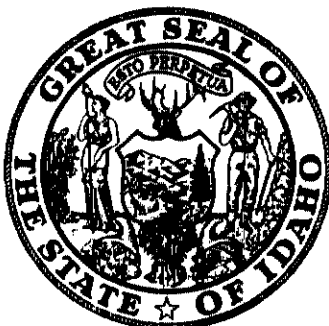
### CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION  
OF

KNOWN ALL MEN BY THESE PRESENTS, That we, the undersigned, being of natural persons of full age, citizens of the United States and residents of the State of Idaho, in order to form a corporation do hereby voluntarily associate ourselves together under and pursuant to the laws of the State of Idaho and do hereby certify and declare as follows:

ARTICLE I

NAME

The name of the this corporation to be used in all its dealings and transactions is HOME ART CORPORATION, INC..

ARTICLE II

PURPOSE

The purpose of this corporation is for the construction, building, purchasing and selling of land and homes, and to further engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

#### ARTICLE IV

##### REGISTERED OFFICE AND AGENT

#### ARTICLE V

##### STOCK

The total authorized number of par value shares of stock is 10,000. The aggregate par value of the total authorized number of par value shares is \$10,000.00.

#### ARTICLE VI

##### CLASS OF STOCK

The corporation is authorized to issue only one class of stock and all issued stock shall be held of record by not more than fifteen (15) persons. Stock shall be issued and transferable only to natural persons who are not nonresident aliens; however the stock shall be nonassignable.

#### ARTICLE IX

##### TRANSFER OF SHARES

No stock of this corporation shall be issued or transferred to any person who is not an officer or director of this corporation, except with the consent of the board of directors evidenced by a resolution duly passed at a regular meeting of the board or at a special meeting called for that purpose. Every shareholder who for any reason shall cease to be an officer or

director, his personal representatives, legatees or assigns shall be required to offer in writing to sell to the board of directors the number of shares of the capital stock held by them to such person or persons as the board of directors shall designate by a resolution duly passed at and for the same sum per share as is determined by the parties to be the net worth of the corporation divided by the number of shares issued for the said corporation.

#### ARTICLE X

##### POWERS

The corporation reserves the right to amend, alter, change or repeal any provision contained in this certificate of incorporation in the manner now or hereafter prescribed by law, and all rights and powers conferred hereon on stockholders, directors and officers are subject to this reserved power.

Until the first annual meeting of the stockholders and the election and qualification of the officers, the following persons shall serve as the officers:


