The undersigned, in order to form a corporation pursuant to Idaho Professional Service Corporation Act, certify as follows:

**ARTICLE I**

The name of the corporation is Dr. Howard W. Mylander D.M.D., P.C.

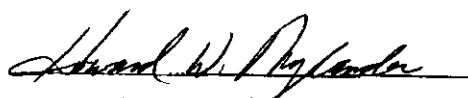
**ARTICLE VII**

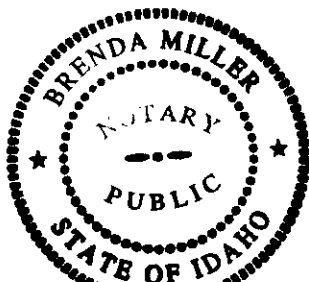

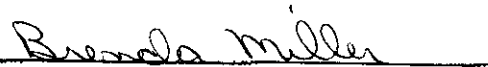
