ARTICLES OF INCORPORATION
OF
J. STEPHEN CRABTREE, P.A.

The undersigned, acting as sole incorporator of a corporation under the Idaho Business Corporation Act and Chapter 13 of said Act, which chapter authorizes the formation of professional service corporations, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is J. STEPHEN CRABTREE, P.A.

SECOND: The period of the corporation's duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the rendering of professional legal services and advice, and the general practice of law.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is ten (10) shares of no par common stock.

FIFTH: Provisions denying pre-emptive rights are: none.

SIXTH: The address of the initial registered office of the corporation is Post Office Box 437-A, Ketchum, Idaho, 83340, and the name of its registered agent at such address is J. Stephen Crabtree.
