ARTICLE 1

The name of the corporation is Wasden Archaeological Association, Inc.

ARTICLE 2

The period of its duration is perpetual.

ARTICLE 3

Section 1. The corporation is organized and shall be operated exclusively for one or more of the purposes specified in IRC §501(c)(3) including without limitation, the preservation and conservation of artifacts, the acquisition, holding, transferring, and management of land, easements and interests in land within, but not limited to, the property known as the "Wasden site" in Bonneville County, State of Idaho, all for the purposes of furthering scientific research, education and information to the public.

Section 2. It is intended that the corporation shall have the status of a corporation which is exempt from federal income taxation under IRC §501(a) as an organization described in IRC §501(c)(3) and which is other than a private foundation by reason of being described in IRC §509(a)(1). These Articles shall be construed accordingly, and all powers and activities of the entity shall be limited accordingly.

ARTICLE 4

Section 1. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 3 above.

Section 2. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including publishing or distributing statements) any political campaign on behalf of or opposing any candidate for public office.

Section 3. Notwithstanding any other provision in these Articles of Incorporation to the contrary, the corporation shall not carry on any activity not permitted to be carried on by a corporation exempt from federal income tax under IRC §501(c)(3), or by a corporation the contributions to which are deductible under IRC §170(c)(2).

ARTICLE 5

Upon dissolution, the corporation's assets shall be distributed for one or more exempt purposes within the meaning of IRC §501(c)(3), or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE 6

Pursuant to Idaho Code §30-30-403, the corporation shall not have members.

ARTICLE 7

Section 1. The board of directors shall consist of no fewer than three (3) individuals. Other than the initial directors, succeeding directors shall be elected by any lawful method set forth in the corporation's bylaws. Unless provided otherwise in the bylaws, the directors shall be elected by vote of the board of directors.

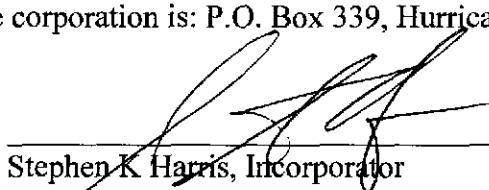
