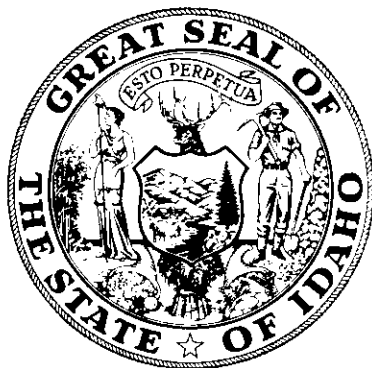

AMENDMENT OF ARTICLES OF INCORPORATION OF

The above-named corporation was organized under the laws of the State of Idaho and was issued a charter by the Secretary of State dated October 3, 1979, with its principal place of business in Pocatello, Bannock County, Idaho.
