#### ARTICLES OF INCORPORATION

FOR

SERVICE STATION MAINTENANCE COMPANY, INC.

The undersigned being all natural persons of the age of twenty-one (21) years or more, and acting as incorporators of a corporation under the Idaho Corporations Act, as admended, adopt the following Articles of Incorporation.

I

The name of this corporation shall be "Service Station Maintenance Company, Inc."

ΙI

The term of this corporation shall be perpetual.

ΙΙΙ

The purpose of this corporation is to engage in the business of installing, maintaining, and repairing service station equipment, and to engage in other businesses not forbidden by law.

ΙV

The name of its registered agent shall be Ronald D. Countryman. The address of its initial registered office is 1239 Willard, Pocatello, Idaho 83201.

The corporation shall have authority to issue five thousand (5,000) share of common stock at a par value of One Dollar (\$1.00) per share, for an aggregate par value of Five Thousand Dollars (\$5,000).
