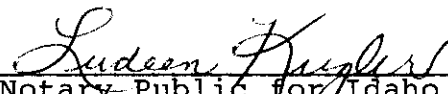
VERLYN JAY PROOST and ELAINE VAN PROOST, each being duly sworn on oath, deposes and for himself says:
