- I, the undersigned person, citizen of the State of Idal, being of legal age and hence capable of contracting, hereby entinto an association to form a corporation under the laws of the State of Idaho and do hereby certify as follows:
- 1) The name of the corporation shall be Monte Smith Siding, Inc.
- 2) The general nature of the business conducted by this corporation shall be the installation of siding and sinsulation in both residential and commercial jobs.
- 3) In the conduct of this business, this corporation shall also have the following powers:
 - to enter into and perform contracts of any and all kinds, to become a partner in any lawful business venture, to acquire and deal in the stock of other corporations, or its own stock and security should the need arise,
 - b) to establish pension and profit sharing plans,
 - assets or merger of corporate structures, or by the exchange of cash, stock, securities, or other consideration,
 - d) to borrow money as necessary and to the extent permissible by law,
 - e) to purchase, lease, or otherwise deal in personal property and dquipment as necessary to the conduct of business
 - f) to purchase, hold, lease, mortgage, or otherwise deal in real property of all kinds,
 - g) to apply for and register patents, trade marks, trade names, and any other intangible objects which may be necessary to the conduct of this business,
 - h) to carry on and conduct any other lawful business in the context of the forgoing powers, as well as to use any other powers available to corporations under the laws of the State of Idaho not specifically claimed or herein enumerated.
