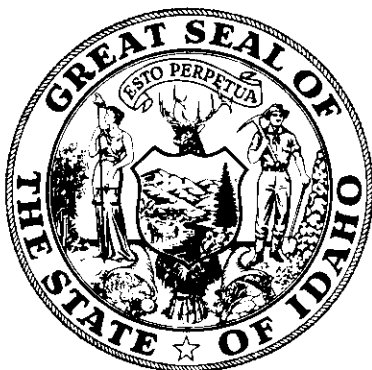

ARTICLES OF INCORPORATION
OF

The undersigned, acting as an incorporator of an Idaho nonprofit corporation adopts the following articles of incorporation for such corporation.

I.

That the name of the corporation is:




