ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation  
under the Idaho Business Corporation Act, adopts the following  
Articles of Incorporation for such corporation as follows:

ARTICLE I

The name of the corporation is BARKER RIVER TRIPS,  
INC.

ARTICLE II

The duration of this corporation shall be perpetual.

ARTICLE III

The purposes and objects for which this corporation  
is formed are as follows:

To transact any and all lawful business for which  
corporations may be incorporated under the Idaho Business  
Corporation Act, including, but not limited to, outfitting and  
guiding river trips and such other activities as allowed by the  
Idaho Outfitters and Guides Licensing Board, and to also  
conduct said business in the States of Washington and Oregon.

ARTICLE IV

The Corporation shall have authority to issue One  
Thousand (1,000) shares of stock, which will consist of Five  
Hundred (500) shares of Class A Stock, being voting shares, and  
Five Hundred (500) shares of Class B stock, being non-voting  
shares. All shares shall have One Dollar (\$1.00) par value.

## ARTICLE V

The address of the initial registered office of the corporation is 2124 Grelle, Lewiston, Idaho 83501, and the name of its initial registered agent at such address is John A.K. Barker.

## ARTICLE VI

The number of directors constituting the initial board of directors of the corporation is five (5) or such other number as shall be established by the By-laws of this corporation, and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

## ARTICLE VIII

No common stock of this corporation shall be transferred on the books of the corporation to anyone not a stockholder or an heir of a stockholder, without the written consent of all common stockholders, unless the common stock shall first be offered for sale to the corporation and secondly to each of the other common stockholders of this corporation at a price and by a method to be determined by the rules and procedures outlined in the By-laws of this corporation or, if not so outlined, for the fair market value of such stock. The By-laws of this corporation shall further prescribe the rules and regulations as to the formalities and procedures to be followed in effecting the transfer of common stock to anyone other than a common stockholder. On the face of each and every certificate of stock issued by this corporation shall be printed a notice as follows: "The transferability of this stock is limited and subject to specific provisions in the Articles of Incorporation of this Corporation."

## ARTICLE IX

The directors shall have the power to make and to alter or amend the By-Laws, to fix the amount to be reserved as working capital and to authorize and cause to be executed mortgages and liens without limit as to the amount upon the property and franchise of this corporation.

## ARTICLE X

The private property of the stockholders shall not be subject to the payment of corporate debts to any extent whatever.

## ARTICLE XI

The method and manner of holding directors' meetings and stockholders' meetings, and the authority and duties of each of the officers of the corporation, and all other matters for management and control of the corporation shall be determined by the By-Laws of this corporation and by the Laws of the State of Idaho.

I, the undersigned, for the purpose of forming a corporation under the laws of the State of Idaho, and restating the Articles of Incorporation do make, file, and record this certificate and do hereby certify that the facts herein stated are true; and I have accordingly hereunto set my hand hereto.
