ARTICLES OF AMENDMENT OF THE AMENDED

ARTICLES OF INCORPORATION OF MIDDLETON METHODIST CHURCH

A meeting of the members of Middleton Methodist Church, a corporation organized and existing under and by virtue of the laws of the State of Idaho, was held at Middleton, Idaho, on the 29th day of April, 1973, at 2:00 p.m. of said day, pursuant to Notice of the meeting published in The News-Tribune, Caldwell, Idaho, on April 7, 14, 21 and 28, 1973.
