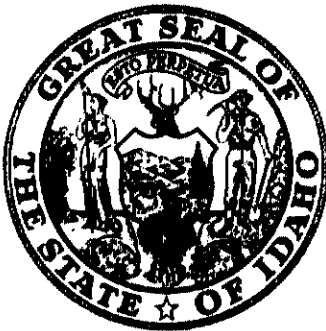
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF
MOUNTAIN WEST ENTERPRISES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is Mountain West Enterprises, Inc.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, including, but not limited to excavating, welding and a machine shop business.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) shares of common stock at \$1.00 par value per share. Such shares are the only class authorized. Transfer of all such shares are subject to restrictions as set forth in detail in the Bylaws of the Corporation; also, a synopsis of such restrictions shall be set forth on the obverse side of all share certificates when and as they are issued.

FIFTH

The address of the initial registered office of the corporation is 530 South 3rd Street, McCall, Idaho, 83638, and the name of its initial registered agent at such address is Timothy Everhart.

SIXTH

The number of directors constituting the initial board of directors of the corporation is one (1) and the name and address of the person who is to serve as director until the first meeting

of the shareholders, or until their successors are elected and shall qualify, is:

Pursuant to Section 30-1-35, Idaho Code, as presently enacted, the powers of the corporation shall be exercised by and under the authority of, and the business and the affairs of the corporation shall be managed under the direction of the shareholders themselves, or the designated officers of the corporation as directed by the shareholders, without the creation or existence of a continuing Board of Directors; save for the initial director(s) named above, the shareholders themselves shall act and function collectively as would directors for all purposes and pursuant to all duties and obligations as otherwise set forth for directors in the Idaho Business Corporation Act.
