ARTICLES OF INCORPORATION

I.

The name of the corporation shall be IMAGE DYNAMICS INT'L., INC.

H.

The period of its duration shall be perpetual.

III.

The objects and purposes for which this corporation is formed shall be and are:

- (a) To engage in the business of producing computer software. To acquire by purchase, lease or otherwise hold, improve, develop, let, see and deal in real and personal properties of all kinds and rights and interests therein. To build, maintain, and operate a computer facility and equipment for producing, testing and marketing its products and supplies.
