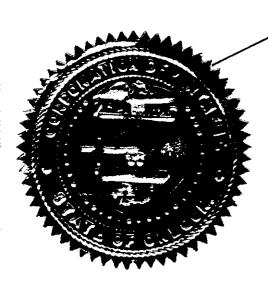

ARTICLES OF INCORPORATION

corporatio	n under and by virtue of the General Laws of the State of Oregon, in force for the formation of
private o	rporations.
	WESTERN ARTICLE I
Th	name of this corporation shall be TRANSPORT LEASING, INC.
and its di	tration shall be PERPETUAL

ARTICLE II

The object of this corporation, and the business in which it proposes to engage is as follows:

- 1. To construct, maintain, own, lease and operate freight terminals and warehouses, including motor truck freight warehouses, depots, storehouses, elevators, repair and machine shops.
- 2. To maintain, own, lease and operate motor truck freight lines over the streets, roads and highways of the state of Oregon and other states and territories of the United States.
- 3. To purchase, sell, lease, deal in, make repairs to, and store automobiles and auto trucks, their parts and accessories, and to buy, sell, own, lease and operate garages, service stations and repair shops and to carry on all business incidental thereto.
- 4. To buy, purchase, lease or exchange real or personal property from or with its directors, stockholders or officers.
- 5. To acquire by exchange for its capital stock, purchase, or otherwise, real and personal property of every kind and the capital stock, bonds or other securities of other corporations or firms.
- 6. To borrow money and issue its notes, bonds, mortgages or other evidences of debt therefor and to make the same negotiable or non-negotiable.
- 7. To hold, use, repair, improve, mortgage, sell, lease, sublet or convey or otherwise handle or dispose of any of its real or personal property, or any interest therein, or any franchise, grant, easement, or right of way or interest therein, or any bond, securities, corporate stock or other property or interest therein.
- 3. Without in any particular limiting or restricting any of the objects and powers of the corporation, it is hereby expressly declared and provided that the corporation shall have power to issue bonds and other obligations, and shares of its capital stock, in payment for property purchased or acquired by it, or for any other lawful object in and about its business; to mortgage or pledge any stocks, bonds or other obligations, or any property which may be acquired by it; to secure any bonds, guarantees or other obligations by it issued or incurred; to guarantee any dividends, or bonds or contracts, or other obligations; to make and perform contracts of every kind and description; and in carrying on its business, or for the purpose of attaining or furthering any of its objects or purposes, to do any and all other things and exercise any and all other powers which a

copartnership or natural person could do and exercise, or which now or hereafter may be authorized by law.

9. Generally to do all other things necessary and proper in the premises in the premotion of the above mentioned objects, all of which powers the said corporation shall be authorized to exercise in the State of Oregon, and in the States and Territories of the United States and elsewhere, and to take out such additional charters and licenses as may be required to be taken out by the laws of the United States, States, territories and other countries as prerequisites of doing business therein.

2. The following amendment of the Articles of Incorporation was adopted by the shareholders of the	he

Article V was amended to read as follows:

4. The manner in which such amendment effects a change in the amount of stated capital, and the amount

The amendment will increase the capitalization of the company to
\$50,000. by transferring \$49,000. from surplus to capital investment,
represented by an increase in shares proportionate to the original stock and capital.
