

We, the undersigned, president and secretary of Long Island Irrigation Company, do hereby certify:

- 1. The name of the corporation is Long Island Irrigation Company.
- 2. The amendments to the Articles of Incorporation of Long Island Irrigation Company, are as follows:
  - A. That Article IV. shall be amended to read as follows:

#### ARTICLE IV.

This corporation shall have perpetual existence from and after this date.

B. That a new Article designated VIII. be added as follows:

#### ARTICLE VIII.

This corporation is a non-profit corporation.

C. That a new Article designated IX. be added as follows:

### ARTICLE IX.

All outstanding shares of the corporation shall continue to be assessable for payment of the obligations of the corporation in the manner and to the extent provided in the By-Laws of the corporation and as said By-Laws may from time to time be amended.

D. That a new Article designated X. be added as follows:

## ARTICLE X.

The capital stock of the corporation may not be transferred except in connection with a transaction involving title to the real property to which that proportion of the water and conveyance rights of the corporation represented by such stock is appurtenant, or as otherwise provided by the By-Laws of the corporation, and only to the extent and in the manner provided in said By-Laws and as the same may from time to time be amended.

E. That a new Article designated XI. be added as follows:

#### ARTICLE XI.

Those shareholders present at an annual or special shareholders' meeting shall constitute a quorum for purposes of transacting any business before the meeting.

- 3. The foregoing amendments to the Articles of Incorporation were adopted and approved at the annual meeting of the shareholders of Long Island Irrigation Company, on February 14, 1981.
- 4. There are / shares outstanding of Long Island Irrigation Company, and the same number of shares is entitled vote on amendments to the Articles of Incorporation.
- 5. At the annual meeting of shareholders of Long Island Irrigation Company, held on February 14, 1981, 35,113.18 shares of stock voted in favor of the foregoing amendments to the Articles of Incorporation of Long Island Irrigation Company, and 0 voted against said amendments.
- 6. Said amendments do not provide for exchange, reclassification or cancellation of issued shares.
