ARTICLES OF INCORPORATION

OF

SEBS CORPORATION, INC.

The undersigned, acting as incorporators under the Idaho
Business Corporation Act, hereby adopt the following Articles of
Incorporation:

ARTICLE ONE

NAME

The name of the corporation is SEBS CORPORATION, INC.

ARTICLE TWO

DURATION

The duration of the corporation shall be perpetual.

ARTICLE THREE

PURPOSES AND POWERS

The purposes of the corporation and its powers are the following:

1. The corporation shall have all powers and purposes specified by the Idaho Business Corporations Act.

ARTICLE FOUR

STOCK
