The undersigned, a majority of whom are citizens of the United States, desiring to form a corporation, not for profit, under Title 30, Chapter 3, Idaho Code do hereby certify:

FIRST. The name of said corporation shall be _____

CLEARWATER VALLEY EAGLES AERIE NO. 3893, FRATERNAL ORDER OF EAGLES, INC.

SECOND: The said corporation shall be a nonprofit corporation.

THIRD. The period of duration said corporation will function, shall be perpetual.

FOURTH. The purpose or purposes for which said corporation is formed are: To conduct, maintain, and carry on the functions of a Local Aerie of the Grand Aerie, Fraternal Order of Eagles, in accordance with the laws and Constitution of said Grand Aerie; and to unite fraternally such persons who are entitled to membership in said Local Aerie, with all rights, privileges and powers as provided by the Constitution and Statues of the Fraternal Order of Eagles.

FIFTH. Membership in said corporation shall be limited to those who are now bonafide members of Clearwater Valley Eagles Aerie No. 3893, Fraternal Order of Eagles, and those who shall hereafter become members of said Local Aerie in accordance with the requirements of the Constitution and Statues of the Fraternal Order of Eagles, now in effect or hereafter enacted.

SIXTH. The officers of said corporation shall be the same individuals as the officers of the Clearwater Valley Eagles Aerie No. 3893, Fraternal Order of Eagles, and the election of said officers shall be at the same time and in the same manner and form and for the same tenure as prescribed by the Statues of the Grand Aerie, Fraternal Order of Eagles, and the approved By-laws of Clearwater Valley Eagles Aerie No. 3893, Fraternal Order of Eagles.

SEVENTH. All assets of this said corporation shall be subject to the laws promulgated by the Grand Aerie, Fraternal Order of Eagles, and title to all assets of this corporation shall pass to the Grand Aerie upon the dissolution of said corporation and/or the revocation or surrender of the Charter issued to it as a Local Aerie of the Fraternal Order of Eagles. No real estate shall be purchased, leased, acquired, sold, or mortgaged, or any permanent improvements made thereon by this corporation, except upon the approval of the proper authority of the Grand Aerie, Fraternal Order of Eagles, and in the manner as provided by the laws of the Fraternal Order of Eagles.

EIGHTH. This Aerie is incorporated in conformity with, subject to and under the jurisdiction and control of the laws of the Fraternal Order of Eagles.
