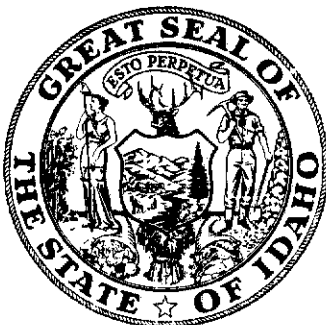

The undersigned incorporators, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is **ROTO ROOTER OF NORTH IDAHO, INC.**

ARTICLE II

PURPOSE

The purpose of the corporation is to carry on the business of a plumbing, sewer and drain cleaning service with all of its ramifications; to render professional and technical services in connection therewith; and to engage in such other activities as are incidental to or connected with the operation of such business. The corporation may also purchase, own, lease or sell real and personal property; enter into leases as landlord or tenant; enter into contracts for any lawful purposes for carrying on the business of plumbing, sewer and drain cleaning service; or to engage in any and all business, acts or things necessary, proper, or convenient for or incidental to the carrying out of the powers or purposes herein mentioned.

The corporation may also conduct business and otherwise carry out its purposes and exercise its powers in any state, territory, district or possession of the United States, or any foreign country, to the extent that these purposes and powers are not forbidden by the laws of the state, territory,

district or possession of the United States, or by the foreign country; and it may limit the purpose or power that it proposes to carry out or the powers it proposes to exercise in any application to do business in any state, territory, district or possession of the United States, or any foreign country.

ARTICLE III

DURATION

The period of existence and duration of the life of this corporation is perpetual.

ARTICLE IV

REGISTERED OFFICE AND AGENT

The address of the corporation's initial registered office in the State of Idaho is 123 South Third Avenue, Suite 3, City of Sandpoint, County of Bonner, State of Idaho; and the name of its initial registered agent at such address is Savi Grewal.

ARTICLE V

CAPITAL STOCK

The aggregate number of shares which the corporation shall have authority to issue is Ten Thousand (10,000). The total authorized number of shares shall be without par value. The stock of the corporation shall consist of one class denoted as Common Stock, each share being entitled to one vote.

ARTICLE VI

DIRECTORS

The number of directors constituting the initial board of directors is two (2) and the names and addresses of the persons who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified are:

REGULATION OF INTERNAL AFFAIRS

The Bylaws may contain any provision for the regulation and management of the affairs of the corporation not inconsistent with the corporate laws of the State of Idaho or these Articles of Incorporation.

PREEMPTIVE RIGHTS

There are no provisions denying preemptive rights.

The foregoing Articles of Incorporation are executed this 1st day of May, 1997.

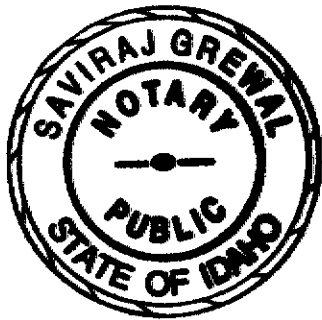


