Know all men by these presents, that we the undersigned have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And we hereby certify:

I.

That the name of said corporation is the Salmon River Milling Company, Limited.

II.

That the purposes for which it is ~~formed~~ formed are to carry on the business of buying and selling wheat and cereals, milling wheat, selling flour and carrying on a general milling business.

III.

That the place where its principal business is to be transacted shall be the town of Salmon City, Lemhi County, Idaho.

IIII.

That the term for which this Incorporation is to exist is fifty years from and after the date of its incorporation.

V.

That the number of its directors shall be five, and that the names and residences of those who are appointed for the first year are:
