The undersigned, in order to form pursuant to Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is Associated Companies Incorporated (hereafter "Corporation").

The private property of the stockholders of this Corporation shall not be the subject to their payment of the corporate debts in any amount or to any extent whatever.


