ARTICLES OF INCORPORATION

The undersigned, acting as the incorporators of a nonprofit corporation (hereinafter "Corporation") organized under and pursuant to the Idaho Nonprofit Corporation Act, hereby adopt the following Articles of Incorporation.

I.

The name of the Corporation is Family Child Care Association of Kootenai County, Incorporated.

II.

The Corporation is a nonprofit corporation.

III.

The period of duration of the Corporation is perpetual.

IV.

The address of the initial registered office is 4201 Staples, Coeur d'Alene, ID 83814, and the name of the initial registered agent at this address is Cheryl Stafford.

٧.

The purposes for which the Corporation is organized and for which it will be operated are to support child day care providers in Kootenai County through education and encouragement so that they may better provide for the needs of their child clients, and to exercise all powers granted by law necessary and proper to carry out the above stated purposes, including but not limited to, the

power to accept donations of money, property, whether real or personal, services or any other thing of value. Nothing herein contained shall be deemed to authorize or permit the Corporation to carry on any business for profit, to exercise any power, or to do any act that a corporation formed under the Idaho Nonprofit Corporation Act, or any amendment thereto or substitute therefore,

VI.

may not at any time lawfully carry on or do.

No part of the earning or assets of the Corporation shall inure to the benefit of or be distributable to its members, directors or other private persons except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article V hereof. No substantial part of the activities of the Corporation shall be the carrying on of activities not permitted to be carried on by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code.

VII.

The Corporation shall have members who shall have such rights as are provided in the Idaho Nonprofit Corporation Act and which are consistent with the management and authority that these Articles grant the Board of Directors of the Corporation. Any person may become a member of the Corporation upon payment of the dues fixed by the Board of Directors.

VIII.

The affairs of the Corporation shall be managed by its Board

of Directors. The Board of Directors shall consist of not less that three nor more than seven individuals each of whom at all times shall be a member of the Corporation, the actual number of directors shall be fixed by the Bylaws of the Corporation. Other than the directors constituting the initial Board of Directors, the directors shall be elected by the members in the manner and for the term provided for in the Bylaws of the Corporation.

Membership dues may be charges to all members or classes of members in equal amounts or in different amounts or proportions upon different members or classes of membership and some members or classes of membership may be made exempt from such membership dues. The Board of Directors is authorized to fix the amount of membership dues from time to time, and to make them payable at such times or intervals, and upon such notice, and by such methods as the Board of Directors may prescribe.

Χ.

Upon dissolution of the Corporation, the Board of Directors, shall after paying or making provision for the payment of all liabilities of the Corporation, distribute the assets of the

Corporation, consistent with purpose of the Corporation to such organization or organizations as shall at the time qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, in such a manner as the Board of Directors shall determine. Any assets not so distributed, shall be distributed by the district court of the county in which the principal office of the Corporation is then located, exclusively for such purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation.
