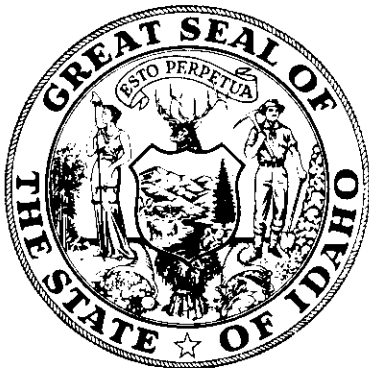

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporations Act, the undersigned, being the sole incorporator of A & A Market, Inc., hereby amends the Articles of Incorporation of A & A Market, Inc.

FIRST: The name of the corporation is A & A Market, Inc.

SECOND: The following Amendment to Articles of Incorporation is hereby adopted:

ARTICLE I of the Articles of Incorporation shall be deleted and replaced in its entirety by the following new ARTICLE I:

ARTICLE I

THIRD: No shares of stock of the corporation are outstanding.
