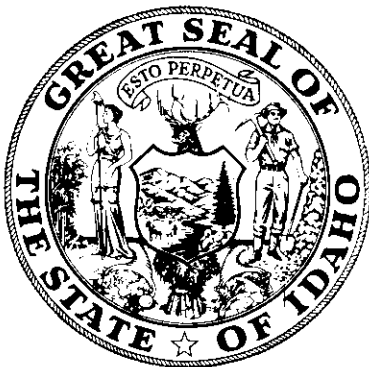

ARTICLES OF AMENDMENT




