MINUTES OF MEETING OF STOCKHOLDERS  
of LITTLE WOOD RIVER CANAL COMPANY.

The regular annual meeting of the stockholders of Little Wood River Canal Company was held at the regular meeting place of the company at Carey, Idaho, on the 9th day of February, 1948, at 2:00 o'clock p.m. of said day, Kenneth Eldredge acting as chairman of said meeting, and Bessie Stanford, acting secretary, ~~as~~ secretary thereof. Whereupon, a check-up was made to determine what amount of stock was present at said meeting, from which it appeared that stockholders representing and owning more than two-thirds of all the capital stock of the company were present at said meeting. It further appeared that due notice of the holding of said meeting had been given by publication of notice thereof in the Hailey Times, a weekly newspaper published at Hailey, in Blaine County, Idaho, and by written notice being served upon all of the stockholders by mail more than ten days prior to the date of such meeting. It appeared that a copy of the notice so given is as follows:

Said resolution was duly put to a vote of the stockholders and all stockholders present voted in favor thereof, and said resolution was declared by the chairman duly passed and adopted.
