PLUS AID FAMILIES WITH MINOR CHILDREN WHO LIVES HAVE BEEN FINANCIALLY DEVASTATED BECAUSE OF ALS.

ATTACHMENT B.....ARTICLES OF INCORPORATION

ARTICLES OF INCORPORATION OF THE UNDERSIGNED, DESIRING TO FORM A NON-PROFIT CORPORATION UNDER SUCH LAW OF THE STATE OF IDAHO.

1. NAME OF CORPORATION - ALS AWARENESS CORPORATION
2. THE PLACE IN THIS STATE WHERE THE OFFICE IS LOCATED IS THE CITY OF HAILEY, BLAINE COUNTY. THE INITIAL REGISTERED AGENT AT THIS OFFICE WILL BE PAMELA P. BAKER.
3. SAID CORPORATION IS ORGANIZED FOR CHARITABLE PURPOSES; AND FOR SCIENTIFIC RESEARCH FOR THE CURE OF ALS BY MAKING DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT UNDER SECTION 501 (C)(3) OF THE INTERNAL REVENUE CODE, AND ARE QUALIFIED TO CONDUCT SUCH RESEARCH; AND TO HELP INFORM THE GENERAL PUBLIC AS TO THE DEVESTATING EFFECTS OF AMYOTROPHIC LATERAL SCLEROSIS; AND TO FINANCIALLY HELP FAMILIES WHO LIVES HAVE BEEN DEVASTED BY THIS DISEASE.
4. THE INITIAL BOARD OF DIRECTORS ARE:

THIS BOARD IS ALSO THE INCORPORATORS.
5. THE CORPORATION WILL NOT HAVE MEMBERS, OR MEMBERSHIPS.
6. NO PART OF THE CORPORATIONS NET INCOME SHALL INURE TO OR BE DISTRIBUTABLE TO ANY MEMBERS, DIRECTORS, TURSTEES, OFFICERS, OR PRIVATE PERSONS EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISBURSMENTS IN FURTHERANCE OF THE PURPOSES SET FORTH IN ARTICLE 3 THEREOF. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THE CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, OR TO PARTICIPATE OR INTERVENE IN ANY POLITICAL CAMPAIGN FOR ANY CANDIDATE FOR PUBLIC OFFICE. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THIS CORPORATION SHALL NOT, EXCEPT IN AN INSUBSTANTIAL WAY, ENGAGE IN ANY ACTIVITIES OR EXERCISE ANY POWER THAT IS NOT IN FURTHERANCE OF THE PURPOSE OF THIS CORPORATION.
7. UPON THE DISSOLUTION OF THE CORPORATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING TO ANY OTHER FUTURE FEDERAL TAX CODE.
