ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, That, <sup>are</sup> we whose names <sup>are</sup> hereto subscribed, do, under and by virtue of the laws of the State of Idaho hereby organize, constitute, associate ourselves and such other persons as may hereafter become associated with us, into a body corporate and politic, and to that end, execute this instrument, which, when certified, filed and recorded as required by law, shall constitute the articles of incorporation of the Payette Irrigation Company, Limited, of Payette, Idaho, and we do hereby certify,

FIRST, That the name of this corporation is the Payette Irrigation Company, Limited.

SECOND, That the purpose for which it is formed and its powers under its corporate name and organization is to <sup>own</sup> establish and maintain a lateral ditch and irrigating canal, <sup>(including rights-of-way)</sup> for the owning, carrying and distribution of water to its shareholders and generally to do all of the things incident to or connected with the irrigating of land and town lots.

THIRD, That the place where its principal business is to be transacted is Payette, Canyon County, Idaho,

Fourth, That the term for which this corporation shall exist is fifty years.

FIFTH, That the number of the directors of this corporation shall be FIVE. The names of the directors selected for the first year and their place of residence are as follows;
