**ARTICLES OF INCORPORATION OF

KNOW ALL PESONS BY THESE PRESENT, That we, the undersigned, each being a natural person of full age, and a citizen of the United States of America, have voluntarily and do hereby associate ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho, and we do hereby certify, declare and adopt the following Articles of Incorporation:

I

CORPORATE NAME

The name of this non-profit corporation shall be "Idaho Education Foundation, Inc."

II

EXISTENCE

The period of existence and duration of the life of this non-profit corporation shall be perpetual.

III

REGISTERED AGENT

The name, location and address of the registered agent */mailing address* and registered office of this non-profit corporation shall be Sallie Herrold: 2499 N. Corsey Way, Eagle, ID 83616

The names and addresses of the initial Directors of this non-profit corporation shall be Sallie Herrold, Kali Kurdy, Liza Walton.

IV

PURPOSES

The nature of the business and the objectives and purposes of this non-profit corporation shall be exclusively for charitable and educational purposes under Section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code.

V

DIRECTOR POWERS

In furtherance, and not in limitation of the powers conferred by statute, the Board of Directors is expressly authorized to exercise, conduct, manage and control the powers, business, affairs and property of the non-profit corporation, and to make such rules and regulations which are consistent with these Articles and the laws of the State of Idaho as they may deem best, all of which as set forth in the By-Laws of this non-profit corporation.




