

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, Frank W. Kettenbach, William F. Kettenbach, George H. Kester, Edward C. Smith and James E. Babb, citizens of the United States and residents of Lewiston, Nez Perce County, State of Idaho, a majority of whom are freeholders in the state of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a private corporation, and we do hereby form and become a corporation under the laws of the state of Idaho, and do hereby adopt the following Articles of Incorporation:

ARTICLE I.

The name of this corporation shall be Kettenbach Co., Limited.

ARTICLE II.

The objects and purposes for which this corporation is formed are as follows:

To carry on a general grain business, a general commission and brokerage business, a general insurance agency, and to loan and borrow money, and to do any and all other things necessary or incidental to the business aforesaid, or any part thereof, for the purpose of aiding, expediting and carrying on the same.

ARTICLE III.

The amount of capital stock of this corporation shall be Fifty Thousand (\$50,000.00) Dollars, divided into five hundred (500) shares of the par value of One Hundred (\$100.00) Dollars each.

ARTICLE IV.

The term for which this corporation is formed is the period of fifty (50) years from and after the date hereof.

ARTICLE V.

The number of Directors of this corporation shall be five (5), and the names and residences of the directors who are hereby selected and appointed to manage the affairs of this Company for the first year, and until the election and qualification of their successors, are as follows:
