AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a body politic and corporate, by the name stated in the articles, for the term of fifty years.

ARTICLES OF ASSOCIATION  
THE DAVIS-MAGLEBY COMPANY

We, the undersigned, do hereby associate ourselves together for the purpose of forming a corporation under and by virtue of the laws of the State of Idaho. And we do hereby adopt the following as our articles of association:

ARTICLE 1. The name of the corporation hereby formed is THE DAVIS-MAGLEBY COMPANY of Idaho Falls, Idaho.

ARTICLE 2. The object and purpose for which this association is formed is to buy, sell, barter, market, and otherwise dispose of farm products and to carry on any and all business incident thereto.

ARTICLE 3. The amount of capital stock of the corporation is \$10,000 and the same is divided into 1000 shares of \$10 each.

ARTICLE 4. The amount of capital stock actually paid is \$1000.

ARTICLE 5. The names of the stockholders, and their respective places of residence, and the number of shares held by each are as follows:

ARTICLE 6. The office for the transaction of the business of this corporation is located at the city of Idaho Falls, county of Bonneville, State of Idaho, and said corporation is to be carried on in said County of Bonneville.

ARTICLE 7. The term of existence of this corporation shall be fifty years from the date of the execution of these articles.

ARTICLE 8. The conduct and management of the business of this corporation shall be controlled by a board of three directors who shall be elected from the stockholders of this corporation on the day of the execution hereof, who shall hold their office for one year and until their successors shall be elected. And the annual election of directors shall be held on the Second day of June each year thereafter during the existence of this corporation.

ARTICLE 9. There shall be elected from said board of directors a President, Secretary-Treasurer, whose duties shall be designated in the by-laws and not inconsistent with the laws of the State.
