ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporators of D & H ENTERPRISES, INC., a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is D & H ENTERPRISES, INC.

SECOND: The period of its duration is perpetual.

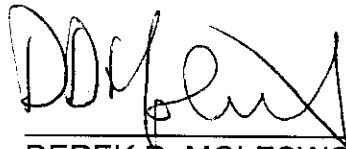
