

ARTICLES OF INCORPORATION OF

THE UNION CANAL COMPANY.

ARTICLE I.

This certifies that we, the undersigned, have this sixth day of January 1897, formed a corporation for the purposes herein after specified, and which shall be known as the Union Canal Company and which shall have the powers and privileges allowed by law.

ARTICLE II.

The purposes for which this corporation is formed are to construct and own canals, and acquire water rights, to take water from Snake River for agricultural purposes, and for domestic use, The headgate of its main canal being located on the left bank of Snake River, at a point about one half mile below the Anderson headgate, in section 5, T. 3. N. R. 41. E. B. M. Bingham county Idaho.

ARTICLE III.

The place where its principal business is to be transacted is Idaho Falls, Bingham County, Idaho.

ARTICLE IV.

This corporation is to exist for the term of fifty years.

ARTICLE V.

The number of its directors shall be five, and the names and residences of those who are appointed as directors, until their successors are elected by the stockholders on the thirtieth day of January 1897, are as follows

ARTICLE VI.

The amount of the capital stock of the corporation is fifty thousand dollars, and is divided into two thousand shares, each share of twenty five dollars, to be equivalent, when stock is issued to one fourth of a cubic foot of water per second to be confined to certain specified tracts of land, as set forth in the water right deeds, and to be inalienable perpetually, subject to the by laws of the company as to water rentals and assessments as they conform to the statutes of Idaho.
