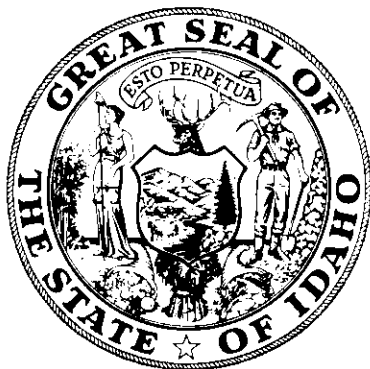

KNOW ALL MEN BY THESE PRESENTS:

THAT the INCORPORATORS who are MARVIN H. WICKLUND, DRISCOLL J. HOLMAN and JACK J. STREIBICK do form a corporation under and pursuant to the laws of the State of Idaho, and do hereby certify as follows:

FIRST

The name of the proposed corporation is CLEARWATER *Lewiston* INVESTORS, INC..

SECOND

The purposes for which this corporation is formed are as follows:

a. Principally to engage in buying and selling real estate for investment purposes.

b. In addition thereto to engage in any or all lawful business for which corporations may be organized under the Idaho law concerning business for profit corporations and which is permitted by the laws of the State of Idaho.

THIRD

This corporation shall have perpetual existence.

FOURTH

That the capital stock of this corporation shall consist of Twelve shares of common stock having a par value of Ten Thousand Dollars (\$10,000.00) per share and an aggregate par value of One Hundred Twenty Thousand Dollars (\$120,000.00).

The capital stock of this corporation shall not be divided into classes, but shall consist of only one class, that being common stock.

The By-Laws of this corporation shall prescribe the rules and regulations setting out the formalities and procedures to be followed in effecting the transfer of common stock and regulating the use of corporate property.

SIXTH

The operations of this corporation are principally to be conducted in the county of Nez Perce, State of Idaho. The office of the corporation will be located in the City of Lewiston, County of Nez Perce, State of Idaho.
