ARTICLES OF INCORPORATION

OF

IDAHO TIRE DEALERS ASSOCIATION, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Non-Profit Corporation Act, adopt the following Articles of Incorporation for such corporation:

<u>PARAGRAPH FIRST</u>: The name of the corporation shall be Idaho Tire Dealers Association, Inc.

<u>PARAGRAPH SECOND</u>: The corporation shall be a non-profit corporation.

PARAGRAPH THIRD: The period of its duration is perpetual.

<u>PARAGRAPH FOURTH</u>: The purposes for which this corporation is formed and will be operated are exclusively related for the benefit and furtherance of the trade association:

a. The specific and primary purposes are:

1. To promote standards of ethics.

2. To coordinate the efforts of its members and their relationship with the public.

3. To promote cooperation between members and local, state, and national problems affecting the tire and retreading industry and it's allied services.

4. To advance and safeguard the business interest of its members.

5. To promote harmony, good-will, and understanding ARTICLES OF INCORPORATION OF IDAHO TIRE DEALERS ASSOCIATION, INC. - 1

among its members.

6. Its purposes shall not be for profit and no part of the income of the association shall be distributable to it's members, directors, or officers.

7. The general purposes and powers are to have and exercise all rights and powers conferred on non-profit corporations under the laws of the state of Idaho.

PARAGRAPH FIFTH: Provisions for the regulation of the internal affairs of the corporation are: None.

PARAGRAPH SIXTH: The address of the initial registered office of the corporation is 2401 South Owyhee Street, Boise, Idaho 83705, and the name of its initial registered agent at such address is Gene E. Anderson.
