The undersigned persons, in order to form a corporation pursuant to the Idaho General Business Corporations Act (Idaho Code, §30-1-1 et seq.) certify as follows:

The name of this Corporation is: **ZANE'S MANUFACTURED HOME SERVICE**, **INC.** 

ARTICLE I.

#### ARTICLE II.

The period of existence and duration of the life of the Corporation shall be perpetual.

#### ARTICLE III.

The purposes and objects for which this Corporation is formed, and the general powers which this Corporation may exercise, are as follow:

- (a) To carry on and conduct the business of the installation of manufactured homes; and
- (b) To transact any and all lawful business for which a corporation may be incorporated in the State of Idaho under the General Business Corporations Act, I.C. § 30-1-1 et seq., and to exercise any and all such corporate powers provided by said Act.
