

ARTICLES OF INCORPORATION

OF

NEW GENERATION ENTERPRISES, INC.



The undersigned, a natural person of the age of twentyone years, or more, acting as incorporator under the Oregon
Business Corporation Act, hereby adopts the following Articles
of Incorporation:

ARTICLE I

The name of the Corporation is:

NEW GENERATION ENTERPRISES, INC.

and its duration shall be perpetual.

ARTICLE II

The purpose or purposes for which the Corporation is organized is to engage in the business of operating retail clothing stores and the sales of general merchandise to the public. The Corporation may engage in any lawful activity for which Corporations may be organized under ORS Chapter 57.

ARTICLE III

The aggregate number of shares which the Corporation shall have authority to issue is 2,500 shares of stock, each to be of no par value.
