KNOW ALL MEN BY THESE PRESENTS: That the undersigned, being natural citizens of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general laws of the State of Idaho, do hereby certify as follows:

## ARTICLE I

The name of the Corporation shall be GOLD PROJECTS This corporation is a non-profit organization as set LIMITED. forth under Title 30, Chapter 3, Idaho Code.

### ARTICLE II

The Corporation's purposes are:

### ARTICLE III

The corporation is to have a perpetual existence.

## ARTICLE V

This is a non-profit organization with members. The management of the affairs of the corporation is to be vested in its members pursuant to Section 30-314(c), Idaho Code. There may be different classes of membership, as provided by Section 30-308, Idaho Code. Such classes of members and manner of election or appointment, and the qualifications of the rights of the members of each class shall be set forth in the By-Laws.
