

Pursuant to the provisions of §30-1-61 of the Idaho Business Corporation Act, SCIENTECH, Inc. has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is SCIENTECH, Inc.

II

The following amendments of the Articles of Incorporation were adopted by the shareholders of the Corporation on October 13, 1994, in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED, that Article IV of the Articles of Incorporation of SCIENTECH, Inc. be amended to read as follows:

IV

The aggregate number of shares which this corporation shall have authority to issue shall be 6,000,000 shares of nonassessable voting common stock having a par value of one cent per share.

III

The number of shares of the Corporation outstanding at the time of such adoption was 1,993,252 and the number of shares entitled to vote thereon was 1,993,252.

IV

The number of shares voted for such amendment was 1,925,080 and the number of shares voted against such amendment was 254.


