I.

The name of the corporation shall be the "Spirit Valley Lumber Company."

II.

The objects and purposes for which this corporation is formed and organized are:

(a) To buy, locate, lease and otherwise acquire, own, hold and control, sell, lease, convey and otherwise deal in and dispose of timber and timber lands in the States of Washington and Idaho, and elsewhere.

(b) To buy, own, lease and otherwise acquire, establish, construct, improve and develop water, steam, electric, and other power plants and stations and to operate and use same

plants and systems, and to operate and use same. .

(c) To buy, own, lease, establish, construct, improve, develop, control and operate saw mills and saw mill plants for the purchase, manufacture and sale of lumber, and all kinds of timber and lumber products, in the States of Washington and Idaho and elsewhere.

(d) To buy, sell and deal in merchandise of all kinds.

(e) To borrow money in furtherance of the purposes for which this corporation is organized, to execute notes evidencing same, and to execute mortgages and other forms of securities to secure the payment thereof.

(f) To do and perform all other acts or things necessary or proper to be done incidental to the purposes hereinbefore set forth, within the United States of America, or any territory or possession thereof, or within the Dominion of Canada, or within any and all of said territories.
