## CERTIFICATE OF AMENDMENT TO AMENDED ARTICLES OF INCORPORATION

of

#### SNAKE RIVER POWER ASSOCIATION, INC.

#### BE IT REMEMBERED:

That at a special meeting of the members of SNAKE RIVER POWER ASSOCIATION, INC., called pursuant to written notice of the time, place and purpose of said meeting, held at the Holiday Inn in Idaho Falls, Bonneville County, Idaho, on the 2nd day of August, 1967, which meeting as will hereinafter more particularly appear from the affidavit of the President and Secretary hereto attached, was duly and legally called, and there was included in the notice of said special meeting of the members, a proposal to adopt an amendment to the Amended Articles of Incorporation of Snake River Power Association, Inc., and a copy of the proposed amendment was included with said notice, a resolution was duly made, seconded and adopted by the vote of the holders of twothirds of the voting power of all members of Snake River Power Association, Inc. to the end and purpose that Article X of the Amended Articles of Incorporation shall be amended to read as follows:

"The number of directors of the corporation shall be at least three, with the exact number to be determined by the By-Laws, and the number of directors may be increased or decreased within these limits from time to time by vote of the members in accordance with the By-Laws of the corporation. Those directors serving at the time of the adoption of this amended Article shall continue to serve until their terms have expired, and until their successors are elected and qualified."
