ARTICLES OF INCORPORATION OF
UTILITIES TRAINING CONFERENCES, INC.

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation.

FIRST: The name of the corporation is UTILITIES TRAINING CONFERENCES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are the preparation, promotion, presentation and sales of training seminars and training seminar material plus any other thing which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, all of which are to be without par value.

FIFTH: The address of the initial registered office of the corporation is 2626 Augusta, Boise, Idaho 83705, and the name of its initial registered agent at such address is Nile H. Miner.

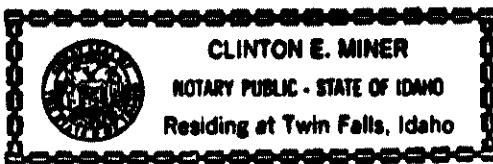
