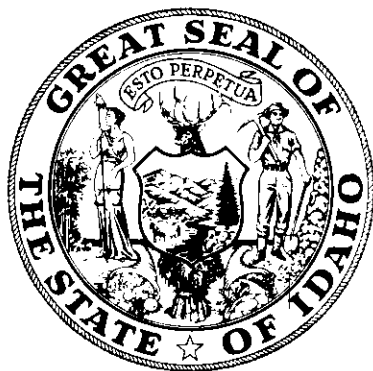

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF  
CO-IDEAS, INC.

WITNESS these Articles of Amendment to the Articles of  
Incorporation of Co-Ideas, Inc., an Idaho Corporation. Pursuant  
to Resolution duly passed in accordance with the terms of Idaho  
Code section 30-1-59, the following items are stated in  
accordance with Idaho Code section 30-1-61:

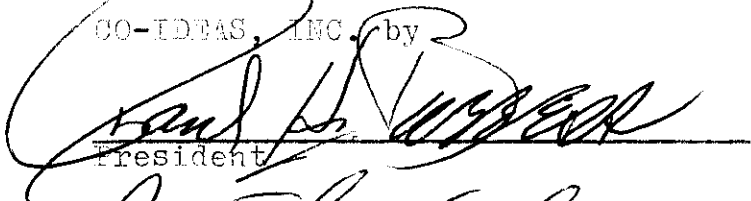
1. The name of this corporation is Co-Ideas, Inc.
2. The amendment adopted is to delete in its entirety  
Article "Tenth", being the paragraph in the original Articles  
of Incorporation captioned and prefaced with the word "Tenth",
3. This amendment was adopted on the 24th day of  
December, 1986.
4. The number of shares outstanding in this corporation  
is 2,000,000 shares of common stock. There were 2,000,000  
shares entitled to vote on the proposed amendment and  
2,000,000 shares were voted by two stockholders in favor of  
the amendment and no shares were voted by any stockholders  
against the amendment.
5. There has been no exchange, reclassification or  
cancellation of any stock of this corporation on account  
of this amendment. However, certain pre-emptive and prefer-  
ential subscription rights of existing stockholders have  
been abrogated and abridged.

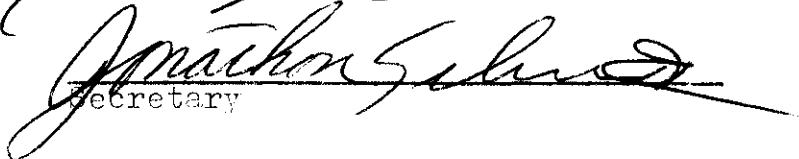
6. There is no change in the stated capital of this corporation as a result of the amendment contained herein.

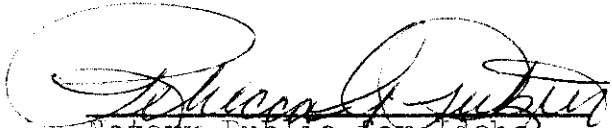
