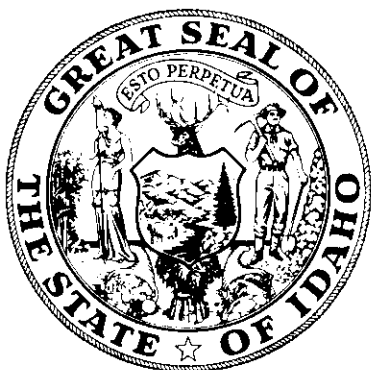

ARTICLES OF INCORPORATION

OF

HOBBS FUR FARM, INC.

The undersigned natural person of the age of twenty-one years or more, acting as Incorporator of a Corporation under the Idaho Professional Corporation Act, adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of this Corporation is Hobbs Fur Farm, *Inc.*

ARTICLE II - DURATION

The duration of this Corporation is "perpetual".

ARTICLE III - PURPOSES

The purpose or purposes for which the Corporation is organized are:

- (a) To engage solely and specifically in the business of carrying on the general practice of
- (b) To invest in real estate, mortgages, stocks, bonds or any other type of investments.
- (c) To own real and personal property necessary for rendering of the above professional services.
- (d) In general, to have and exercise all powers conferred by the laws of the State of Idaho upon professional

corporations and to do all and any things hereinabove set forth to the same extent as a natural person might or could do.

#### ARTICLE IV - STOCK

The aggregate number of shares which this Corporation shall have authority to issue is 50,000 shares of stock at \$1.00 per share.
