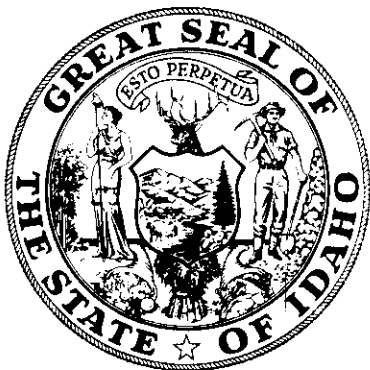

The undersigned Directors, and Shareholders (being all of the Shareholders) of NATIONAL MARKETING AND MANUFACTURING, INC., hereinafter referred to as Corporation under the provisions of Title 30, Idaho Code, hereby certify the following Articles of Amendment to the Articles of Incorporation of NATIONAL MARKETING AND MANUFACTURING, INC., have been affected by Resolution pursuant to Idaho Code 30-1-59, and that said amendment is as follows:

ARTICLE 4

4. It shall have authority to issue ONE MILLION SHARES (1,000,000) all of one class TEN CENTS (10¢) par value.

and further states that Notice as required by law was given unto each and all of the Shareholders; that a resolution for Amendment of Articles was adopted by the Board of Directors and subsequently ratified by the Shareholders by an affirmative vote of the holders of the majority of shares entitled to vote; there are presently FIVE THOUSAND SHARES (5,000) outstanding entitled to vote and of those FIVE THOUSAND SHARES (5,000) all Shareholders voted yes on the amendment and none voted no on the amendment; that such amendment provides for an exchange or reclassification of issued shares and the proposed manner for effecting the exchange or reclassification is an exchange of ONE HUNDRED (100) new shares for ONE (1) of each of the existing shares issued under the previous unamended Articles

of Incorporation and that the stockholder equity remains unchanged; and that the stated capital is unaffected. And FURTHER STATES that no other Articles of the original Articles of Incorporation are changed or affected other than Article 4 as hereinabove set forth.
