# NONPROFIT CORPORATION ARTICLES OF INCORPORATION

AMENDED AND RESTATED

Pursuant to Title 30, Chapters 21 and 30 of the Idaho Code, the undersigned majority of whom are citizens of the United States, do hereby submit these Articles of Incorporation for the purpose of forming a religious, nonprofit corporation.

## ARTICLE 1

### Name

The name of the corporation is Heidi's House Ministries, Inc.

## ARTICLE 2

### Existence

The corporation shall have perpetual existence.

## ARTICLE 3

### Effective Date

The effective date of incorporation shall be 10/12/2022.

## ARTICLE 4

### Members

The corporation will not have members.

### Type of non profit corporation

## ARTICLE 10

### Indemnification

The corporation does indemnify any directors, officers, employees, incorporators, and members of the corporation from any liability regarding the corporation and the affairs of the corporation, unless the person fraudulently and intentionally violated the law and/or maliciously conducted acts to damage and/or defraud the corporation, or as otherwise provided under applicable statute.

## ARTICLE 11

### Purpose

Heidi's House Ministries, Inc. is organized and operated exclusively for charitable purposes in accordance with Section 501(c)(3) of the Internal Revenue Code. More specifically, Heidi's House Ministries, Inc. exists to provide resources and solutions for children

in need including, but not limited to, providing temporary shelter, food, clothing, life skills, education services, and spiritual care for women and children in distress. The motivation for this endeavor is explained in James 1:27 (NIV) which states, "Religion that God our Father accepts as pure and faultless is this: to look after orphans and widows in their distress".

## ARTICLE 12

### Prohibited Activities

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article 11. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

## ARTICLE 13

### Distributions Upon Dissolution

Upon the dissolution of the corporation, after paying or making provisions for the payment of all the legal liabilities of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.

## ARTICLE 14

### Statement of Faith

#### THE SCRIPTURES

We believe that the sixty-six books of the Bible are the word of God, inspired by the Holy Spirit in such a way that they are without error in autograph, convey objective truth, and are the believer's only infallible rule for faith and practice. (2 Pet. 3:16; 1 Tim. 5:18, Jn 10:35, Deut 4:2, 2 Pet. 1:20,21)

#### GOD

We believe in one God who is eternally existent in three persons, namely the Father, the Son (Jesus Christ), and the Holy Spirit. (Col 2:9, 2 Cor 13:14, Mt 28:19, 1 Cor 8:6, Acts 5:3, John 1:1)

### JESUS

We believe that Jesus the Christ, the second person of the Trinity, is the incarnate Son of God and both true God and true man. He was conceived of the Spirit, born of a virgin, lived a sinless life, died willingly, and rose from the grave. (John 1, 1 Corinthians 10:1-4, John 17:5, John 8:58, Heb 4:15, John 19:30-34)

### THE HOLY SPIRIT

We believe in the Holy Spirit's eternal and continuing work in regeneration, sanctification, and preservation. He distributes gifts, by grace, for the empowerment of the saints. No particular spiritual gift signifies or authenticates a sincere faith. A Spirit-filled life is not a life without trials and Spiritual empowerment does not directly relate to physical health or financial well-being at this time. (1 Cor 12:28, Eph 4: 7-16, John 15:18, 2 Cor 12:7)

### GRACE

We believe that God is perfectly holy and just. Humankind has rebelled against God in sin, and such rebellion necessitates eternal damnation. By His grace God has provided a substitutionary atonement through the death of Jesus Christ the Son of God. Whoever repents of their sin, believes in, follows, and accepts Christ as a substitution will experience salvation. (Rom 6:23, Rom 3:24-26; Gal. 4:5; Eph. 1:4-5)

### SALVATION

Salvation is by grace alone through faith alone in the atonement of Jesus Christ on one's behalf. Salvation is attained by grace apart from any human works of merit or ritual. (Eph 2:9)

### THE CHURCH

We believe that the holy Church is a collection of humans who have been related by faith in Jesus the Christ and is distinguished not by heritage, borders, nor by color but rather by unanimous confession that Jesus is Lord and has purchased us with his blood. This unanimous confession and belief should be evidenced by obedience to the word of God. (Rom 12:5, 1 Cor 12:13)

### RELIGION

We believe that "religion that God our Father accepts as pure and faultless is this: to look after orphans and widows in their distress and to keep oneself from being polluted by the world." (James 1:27)
