ARTICLES OF INCORPORATION OF SILVER CORNER BAR AND GRILL, INC.

THE UNDERSIGNED, being each over the age of twenty-one (21) years and citizens of the United States of America, for the purposes of forming a corporation under the Idaho Business Corporations Act, do hereby adopt the following articles of incorporation:

ARTICLE I.

The name of the corporation shall be: SILVER CORNER BAR AND GRILL, INC.

ARTICLE II.

The duration of this corporation shall be perpetual. ARTICLE III.

The purpose for which this corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

ARTICLE IV.

This corporation shall have the authority to issue the following amounts of capital stock at the following par value:

Number of shares authorized: 1,000,000

Par value per share: \$1.00

There shall be no other class or shares of stock in this corporation.

ARTICLE V.

The owners of shares of stock of this corporation shall be ARTICLES OF INCORPORATION - 1.

entitled to preemptive rights to subscribe for or purchase any part of new or additional issues of stock or securities.

ARTICLE VI.

The Board of Directors shall have full power to adopt, alter, amend or repeal the bylaws or adopt new bylaws. Nothing herein shall deny the concurrent power of the shareholders to adopt, alter, amend or repeal the bylaws.

ARTICLE VII.

This corporation reserves the right to amend, alter, change or repeal any provisions contained in its Articles of Incorporation in any manner now or hereafter prescribed or permitted by statute. All rights of shareholders of this corporation are granted subject to this reservation.
