

ARTICLES OF INCORPORATION STATE

OF

KNIGHT COMMUNITY CHURCH, *Incorporated*

KNOW ALL MEN BY THESE PRESENTS: That We, the undersigned persons, all of whom are citizens of the United States of America, and of full age, do hereby voluntarily associate ourselves together for the purpose of forming a non-profit corporation, without capital stock, under and pursuant to Title 30, Chapter 3 of the Idaho Code, and that we do hereby make, acknowledge and declare and adopt the following Articles of Incorporation, to-wit:

I

NAME

The name of this corporation shall be the KNIGHT COMMUNITY CHURCH, INCORPORATED.

II

NO CAPITAL STOCK

This corporation is a non-profit corporation and shall have no capital stock and no dividends or pecuniary profits shall be declared to the members thereof.

III

PURPOSES

The objects and purposes for which the corporation is formed are as follows:

- (a) To bring people to a knowledge of our Lord Jesus Christ, that they may know and do His Will.
- (b) To acquire by purchase, bequest, gift, devise or lease or any other manner, real estate and personal property or any property item or effect

that may become instrumental for the purposes for which the corporation is organized.

- (c) To execute, enter into, make, acknowledge, perform and carry out all contracts, deeds, leases, mortgages, conveyances and any other papers for documents of every kind or nature whatsoever, and to do every act and thing necessarily suitable, convenient or proper for accomplishing any of the purposes herein enumerated or any other lawful purpose, and to exercise all powers now or hereafter conferred by law on associations of this type.
- (d) To make assessments and charges to the members throughout for the services furnished in connection with the purposes hereof, which assessments and charges shall be disbursed by the corporation only in payment of expenses for the purposes herein enumerated, and not as dividends or profits to any member or officer hereof.

#### IV

##### REGISTERED AGENT AND OFFICE

The name and post office address of the registered agent of the corporation shall be JOHN M. CAROTHERS, Route B, Box 265, Grandview, Idaho 83624.

#### V

##### DURATION

The period of existence and duration for this corporation shall be perpetual.

#### VI

##### MEMBERSHIP

Any person shall be eligible for membership in the corp-

oration subject only to the approval process set forth in the By-laws. Membership in the corporation may be evidenced by a membership certificate. There shall be one voting right for each membership. Voting rights, membership and continuation thereof shall be dependent upon each member's continued qualification pursuant to the Constitution and By-laws of the Corporation.

## VII

### AMENDMENT OF ARTICLES

These Articles of Incorporation may be amended as provided for in the Idaho Code Sections 30-326 and 30-327.

## VIII

### BY-LAWS

By-laws not in consistent with the Articles of Incorporation may be adopted, altered, amended, or repealed at any regular meeting of the members, or at any special meeting of the members of the corporation called for that purpose, by the affirmative vote of two-thirds of the qualified members present at such meeting; Provided, However, a quorum, which shall be a majority of the eligible members, shall be present.

## IX

### GOVERNING BODY

The business of this association shall be managed by a Board of Directors and not less than three nor more than nine directors, the number, qualifications, terms of office, manner of election, powers and duties of such director shall be such as shall be prescribed by law, these articles and such Constitution and By-laws as from time to time may be enforced. duly elected and qualified, and who are acting as the incorporators of this corporation, are as follows:
